OA Update – Gary Fogelbach, OA

Gary stated that OA was experimenting with their check stubs being posted online instead of a printed-paper check stub. He likes this system so far and it will be out there as soon as the bugs are worked out. He also state that the pay plan increase of 4% looks to be a go but hasn't been signed yet. If it does pass you can contact Christy to get updated pay grids. The pay increase will be effective on 07-01-06 but will not show on pay stubs until 07-31-06. The FY 2008 budget meeting is set for 1:00 on June 13, 2006 in the Truman Building.
